Mission Statement

To enhance the morale and well-being of Picatinny Community by providing supplemental funding to activities at Picatinny Arsenal.

Vision Statement

The Civilian Welfare Council (CWC) mitigates funding voids to provide activities to the Picatinny workforce that would otherwise go unfunded. The CWC interacts with multiple stakeholders on an individual and organizational level in a fun and social environment to engage new people, create awareness, promote and publicize complimentary programs & events that meet the evolving needs of the community while maintaining oversight and control of the funding used to support these activities.

Funding Eligibility Guidelines:

1. **Intramural athletics and sports:** (e.g., participation in industrial leagues of the civilian community, 5k walks/runs, softball, soccer, bowling teams, etc)
2. **Recreational, social, hobby, or occupational groups open to all employees:** (e.g., clubs, lunch & learns, travel books, youth activities, etc.) Funding will not be approved nor used to cover operational fees)
3. **Special, one-time events:** (entertainment events)
4. **Contests and awards for recreational, morale, and well-being activities:** (e.g., individual and/or group awards such as trophies, plaques or certificates where individual awards cannot exceed \$50 and group awards cannot exceed \$200. EXCLUDES work performance recognition)
5. **Social activities:** (e.g., door prizes, *BBQ's, *picnics, dances, etc. Funds shall not be approved nor used for the purchase, resale or distribution of alcohol).

*BBQ and Picnic support is limited to the rental fee for use of the Lake Denmark Picnic Grounds to each Organization at the Directorate level only, off-site BBQ or Picnic locations will not be supported.

6. **Participation in installation-wide events:** (patriotic, historical, or cultural – e.g., memorial dedications, etc.)
7. **Preventative medicine programs** as approved by local medical officers, EXCLUDES tetanus serum and shots. (e.g. Annual Blood Testing)
8. **Official hosting and representation** benefiting the installation's mission and its internal and external relationships: (requires Garrison Commander approval-- e.g. guest speaker)

This list represents the majority of requests presented to the Picatinny Civilian Welfare Council. While the intricacies of your particular event, program or activity may vary slightly from the examples shown above, it is recommended that your fund request be aligned with one or more of the abovementioned guidelines.
